Cybercrime Doesn't Take a Vacation!

Keeping safe during summer travel goes beyond applying sunscreen, drinking water and packing layers. As tempting as it is to let our guard down, remaining vigilant with technology is part of our everyday lives has become increasingly important.

Before You Go:

- When booking your travel, use secure sites beginning with "https://." You should also see a
 padlock symbol in the address bar.
- Back up your device with a cloud service.
- Use a virtual private network (VPN) to protect your data when connected to uncertain Wi-Fi. In Transit:
- Treat your devices like cash and secure them in public places.
- Remain vigilant about your surroundings and how and where you use your devices.

While You Are There:

- Avoid conducting confidential or financial activities while using a public wireless network. FYI:
 Your cell phone's mobile network connection is more secure than a public wireless network.
- Do not connect to public charging stations. Your data could be stolen via the wires provided. When You Get Home:
- Immediately change your passwords or PINs that were used while travelling.
- Update and run all of the anti-virus/anti-malware programs on your devices.
- Check your financial statements report any suspicious transactions immediately!
